



# ORIC's first RAP

The Office of the Registrar of Indigenous Corporations (ORIC) launched its first Reconciliation Action Plan (RAP) during NAIDOC Week with a free sausage sizzle and some great entertainment from Mary G.

A good crowd gathered in the Woden Town Square in Canberra for the welcome to country by Aunty Ruth Bell and the Registrar's address about the importance of ORIC's first Reconciliation Action Plan. Ms Barbara Livesey, Chief Executive of Reconciliation Australia also spoke and congratulated ORIC on the way the RAP had been developed in consultation with staff and clients.

ORIC's RAP is aligned with the government's plan for closing the 17-year life expectancy gap between Indigenous and non-Indigenous Australians. It outlines what we are currently doing and what is planned to promote reconciliation through the development of actions in the key areas of relationships, respect and opportunities for Indigenous and non-Indigenous people.

## Key areas of ORIC's RAP

### Relationships

Respectful relationships are the fundamental underpinning of reconciliation. These can be nurtured in the workplace by having a balance of Indigenous and non-Indigenous staff working together and spending time together to listen and learn from each other.

### Respect

Respect is the basis of any successful, productive relationship. At ORIC we actively encourage our staff to take part in cultural awareness programs and activities to promote understanding of Indigenous culture.

### Opportunities

An organisational culture that promotes skill sharing and supports Indigenous capacity is in everyone's interest. ORIC intends to recruit more Indigenous staff while retaining a balance to reflect diversity in our decision-making processes.

### Tracking progress and reporting

Internal reporting and external advice on progress towards implementing our RAP will be measured and publicly reported each year.

# Move to CATSI—workshops

Aboriginal and Torres Strait Islander corporations have until 30 June 2009 to move to the new CATSI Act. Now is the time to update your corporation's rule book. ORIC staff will be running workshops to help corporations with their rule books before the deadline—we call them our transition workshops. If you don't have a final rule book by this deadline, the Registrar has the power under the *Corporations (Aboriginal and Torres Strait Islander) Act 2006* (the CATSI Act) to give you a set of rules.

## What's it all about?

The transition workshops are all about helping corporations make the change to the CATSI Act. ORIC will hold workshops around Australia in some Indigenous Coordination Centres.

Corporations who register to attend will work with ORIC staff to draft their rule books in the two days following the workshop. These draft rule books can then be taken back to the community so your corporation members can have a say.

ORIC staff will also demonstrate some of the self-help tools that corporations can use.

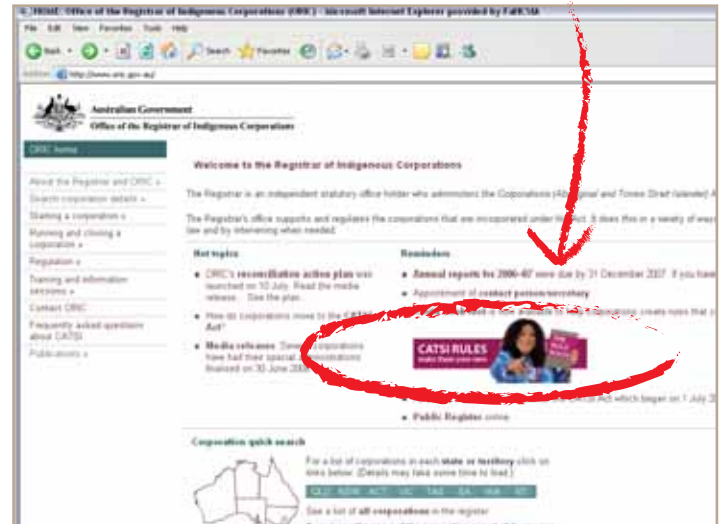

## What do we need to do?

1. Nominate two people who can attend the workshop and who will be responsible for helping your corporation to transition.
2. Make sure the two nominees are prepared to set aside one to two days from their busy schedules to participate actively.
3. Ask your nominees to complete an application form (available from our website or call our freecall number 1800 622 431) and indicate if they would like a follow-up appointment after the workshop.
4. If you have a draft copy of your corporation's rule book, bring it along to the workshop.
5. Have a look at our website ([www.oric.gov.au](http://www.oric.gov.au)) at the different resources we have available to help you with your rule book redesign. For example, we have a very handy rule book etool.

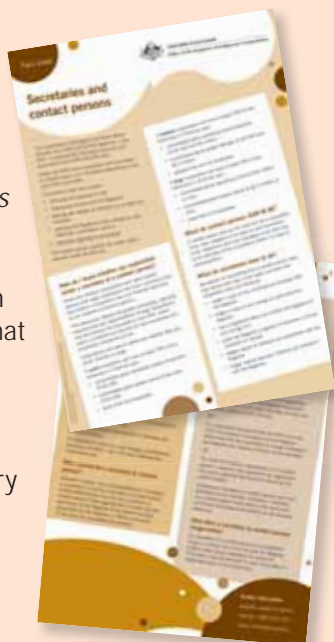

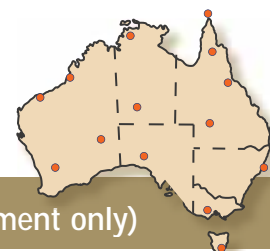
Individual sessions with corporations who need more help with their rule books will be available after the workshop.

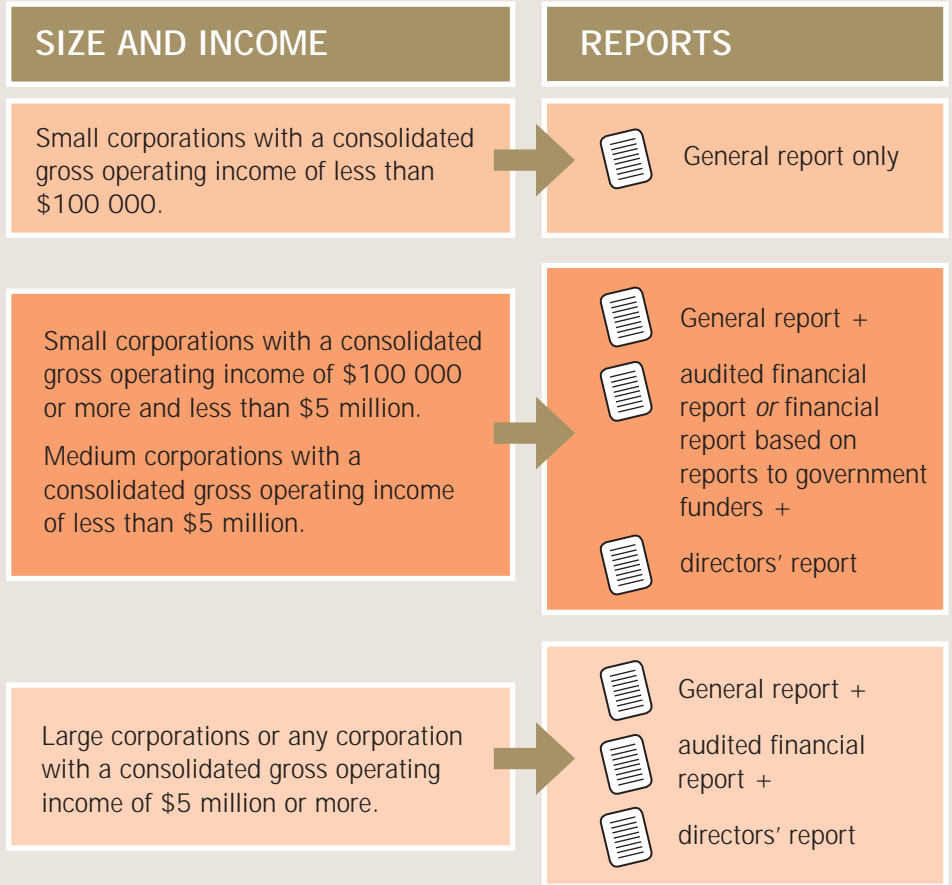

# How's your financial reporting going?

In 2008–09 corporations must report under the CATSI Act as small, medium or large depending on their income and registered size, unless you were one of the few who wrote to the Registrar for an exemption. All reports must be lodged with the Registrar every year between 30 June and 31 December.

You can now also do your reporting online! It's easy and it saves you time. Go to our website and check it out (<https://online.oric.gov.au>). Of course you can still submit it in hard copy if you choose to do so.
